It is the greatest opportunity for me to contact you this time and deeply apologize for disturbing your very tight schedule of time under the significant political issues in the international and domestic fields.

I am Akihiko Yamaguchi, identified by Japanese Passport No. TS2853239, Signatory of the Dragon Family, only Japanese and alone.

In this connection, I sent such a Japanese Letter via mail of post office to US Ambassador Mr. Hagerty of US Embassy in Tokyo on March 19, 2018. Because I expected he would send my Letter in Japanese to U.S. President Trump after properly translated my Japanese Letter into correct English along with all documents.

However, I judge that Mr. Hagerty could not do my requests then, because his around people of US Embassy in Tokyo in 2018 were many people of CIA of Deep State of USA.

Therefore, I decided to re-send my Japanese Letter with other documents as many evidences to U.S. President Trump and Mr. Elon Musk through Mr. Benjamin Fulford in this time by use of E-mail.
